Our capabilities are applied at former military sites during the characterization and remediation process, at active military ranges requiring operational clearance and maintenance, and at private locations where MEC has remained dormant until encountered during intrusive activities. USAE operates under NAICS 562910 for environmental remediation.

With over 26 years of successful project execution, USAE has completed more than 7 million project hours across nearly 2,000 projects valued at \$854 million, serving as both a prime contractor and subcontractor on global project sites.

DAGCAP accredited since 2018, USAE employs a team of more than 158 multidisciplinary subject matter experts with extensive experience in planning and operations for MEC

and HTRW projects. Our team includes program managers, project managers, UXO-related labor categories, field supervisors, safety managers, safety and health professionals, quality managers, UXO-qualified divers, geophysicists, and global logistics experts. This depth of expertise allows USAE to manage all phases of MEC, HTRW, and Operational Range services and support simultaneously across multiple project sites, regardless of geographic location.

USAE applies a comprehensive Corporate Safety and Quality Control Program to every project, ensuring consistent quality and safety standards. This commitment has led to an average Experience Modification Rate (EMR) of 0.87 over the past five years.
