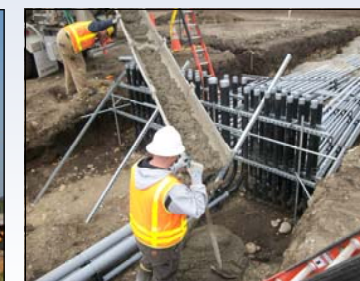

Corporate Overview

USA performs environmental remediation under NAICS 562910. We provide services to locate, identify, remove, and dispose of MEC and UXO using the latest technologies available to achieve the highest levels of safety, cost effectiveness, and quality. USA's Core Capabilities are shown above, which can be applied at former military sites as part of the characterization and remediation process, or within active military ranges that require operational clearances and maintenance. To date, USA has safely and successfully completed over \$685M of MEC work as both a prime contractor and a subcontractor at project sites located throughout the world.

USA employs more than 140 personnel, including all UXO-related labor categories, and maintains both the personnel and equipment to support multiple project sites simultaneously, regardless of geographic location. Our staff consists of highly qualified subject-matter experts who are well-versed in all planning and operational aspects related to the

completion of MEC projects, including safety integration, quality control, project management, field supervision, geophysics, and global logistics support.

Over the past 19 years of successful project execution, USA has performed over 6.3 million field-related manhours of work on over 950 projects, with 6.1 million of those being MEC-related. USA has comprehensive Safety and Quality Control Programs and maintains a Corporate Health and Safety Plan, which is utilized to develop unique Site Health and Safety Plans for each work site. This attention to quality work and safe procedures has led to an average Insurance Experience Modification Rate (EMR) of 0.83 over the last 10 years.

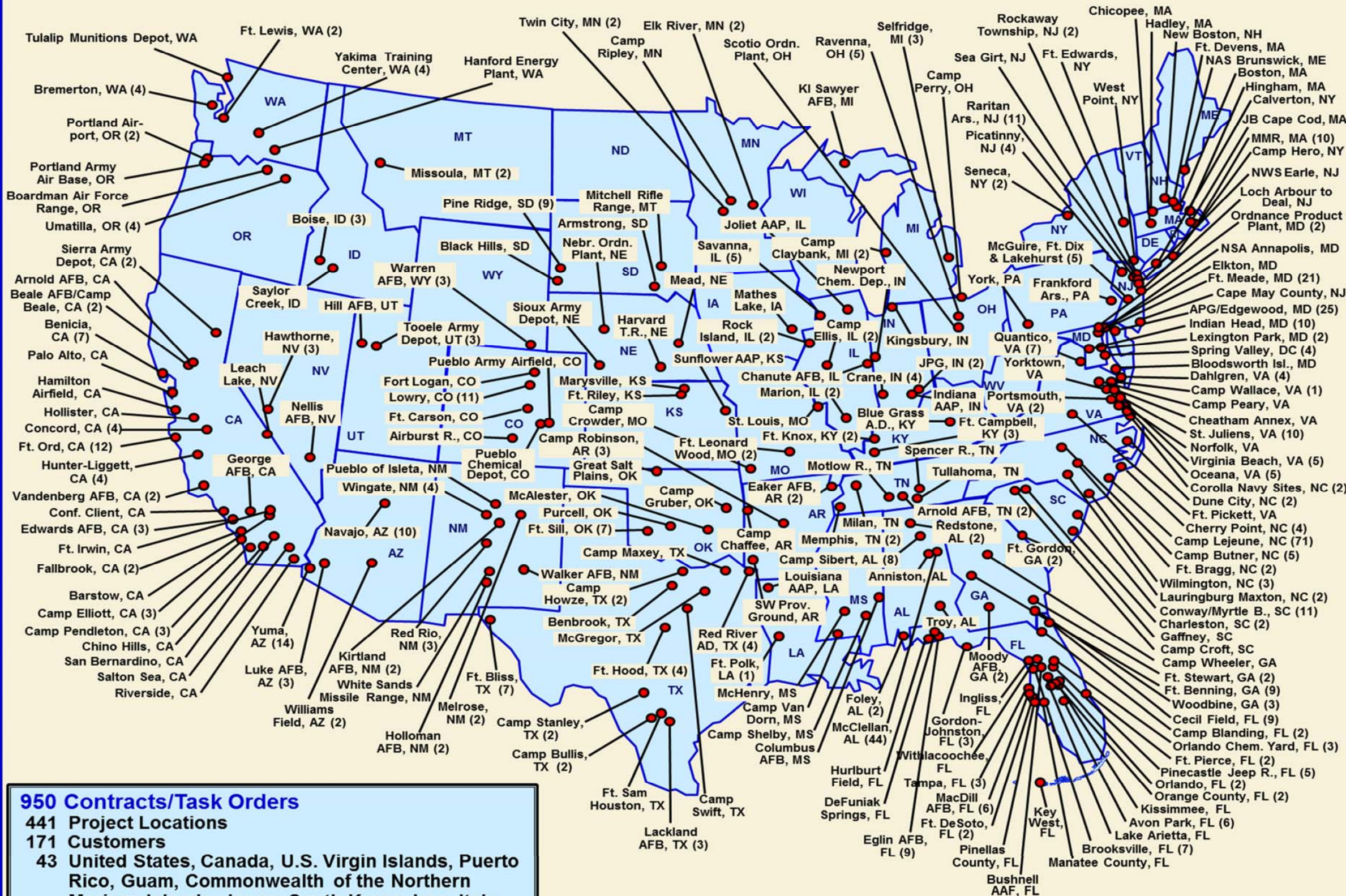
