Over the past 20 years of successful project execution, USA has performed more than 6.55 million field/MEC-related manhours of work on 1,017 projects.

Additionally, USA has safely and successfully completed over \$713M of MEC work as both a prime contractor and a sub-contractor at project sites located throughout the world.

USA employs more than 158 personnel, including all UXO-
