
- The task sponsor develops a brief task statement, including statement of work, list of deliverable products, schedule, and cost estimate
- The task sponsor contacts the Contracting Officer's Representative (COR) at Naval Surface Warfare Center (NSWC), Indian Head Division (IHD) to review requirements
- The COR verifies that the task statement is within scope and has sufficient ceiling
- Upon COR verification, the task sponsor submits funding documents to NSWC IHD: one to accomplish the task and one for a 3 percent fee
- The COR generates the technical instruction (TI). The Contracts Specialist then sends the TI to CACI for signature approval
- Upon receipt of the signed TI from CACI, the Contracts Specialist finalizes details of the contract modification
- The contracting officer reviews, approves, and signs the contract modification to authorize work
- The COR forwards the modification to the task sponsor and Team CACI, including the financial point of contact
- The Team CACI project manager conducts a technical instruction kick-off meeting with the task sponsor and begins work


